

Guarantee

Buyer assume an obligation that the approximately 45% of the price amount as a deposit will be payed to Seller in advance which will be deducted from the total purchase price with the payment of the balance.

If, after sending the deposit, the buyer withdraws from the purchase for reasons beyond the seller's control, the deposit will be forfeited.

The remainder of the full purchase price - with the price of delivery - must be sent to the seller by the latest two weeks before travel.

We strongly recommend that you take out insurance for your puppy after arrival, which can help the new owner to cover any veterinary or other costs that may arise.

The puppy is current on shots and deworming according to the age. Every effort has been made by Seller to insure pup's health. Puppy has been recently examined before the departure appears fully healthy.

Puppy is guaranteed for 12 months (from the date of birth) against genetic defects only if the following guidelines are followed exactly:

- a) The Buyer must notify seller of any genetic defect immediately. If the buyer discloses the problem before notifying the seller, the warranty will be voided.
- b) A written statement as to the genetic defect must be provided to us from Buyer's veterinarian.
- c) A written second opinion from another veterinarian must be provided to us from Buyer.
- d) The puppy must be spayed, natured, picture must be shown of it and vet phone number, contact e-mail address must be provided.
- e) The buyer must return the pedigree of the puppy.
- f) After these guidelines are followed, if there is a genetic defect present we will provide a replacement puppy of the same color and purchase price within 12 months.

The following conditions are covered by this guarantee:

- Heart, pancreas, kidney defects of a severe, life threatening nature. (Imminent paralysis, heart problem that life threatening, chronic pancreatitis.)

This guarantee does not cover:

- Cherry Eye,
- umbilical hernia,
- inguinal hernia,
- loose hips, or any degree of hip dysplasia,
- loose knees,
- infertility,
- allergies,

- bacterial infection of any kind,
- fungus,
- parasitic infection,
- hypoplastic trachea,
- respiratory infections,
- kennel cough,
- demodex,
- tail abnormalities,
- cosmetic issues,
- Buyer's ignorance,
- neglect of incompetent veterinarians or mistreatment,
- any death for any reason if pup dies under anesthesia,
- spine disorders, as relevant professional research shows that this problem is mainly due to the short-nosed twisted-tailed breeds, which have a very high percentage (more than 95%), do not have a clearly identifiable selection program for filtering mature breeding dogs without symphons, which can be used by responsible breeders in practice.

Seller will not be responsible for any medical expenses incurred. Buyer is aware that owning a puppy means trips to the veterinarian and understands that he/she will be responsible for all payments.

Any physical problem which is or could be the result of injury is not covered under this guarantee.

There are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders that are not covered by this guarantee.

It must be an indoor dog.

All items covered under this guarantee are by replacement only. No refunds in part or full will be given.

Buyer is responsible for all the needed paper and transporting costs on the replacement puppy from seller.

No replacement puppy will be given if the puppy has been bred, or euthanized without Seller's permission.

It is understood that the replacement puppy may not be from the exact same parents of original puppy.

This guarantee is null and void if:

The Buyer does not maintain preventative health care of the puppy/dog, including to inoculations, internal and external parasites and heartworm preventative medicine.

Buyer understands and agrees to these conditions of sale. This warranty is only intended for original owner and is not transferable.
